The directors answer only to the membership. America's First has a seven-member board who serve three-year terms upon election by the members. Each year, as board terms expire, a nominating committee is appointed to identify and select qualified candidates to be nominated to fill upcoming vacancies. In 2022, we will have three vacancies on the board of directors.

The Nominating Committee is proud to announce that Dr. Sara Robicheaux, Mr. Eric Housh, and Ms. Karen Bruce have been nominated as candidates for the three vacancies on the board of directors at the Annual Meeting on April 19, 2022. Please mark your calendar for the Annual Meeting to select candidates to serve on the board of directors and to review the highlights of 2021. The annual meeting is scheduled for April 19, 2022 at 3:00 pm, in the auditorium of the Administrative Headquarters of America's First at 1200 Fourth Avenue North, Birmingham, Alabama, 35203. Please be aware that pandemic attendance restrictions may still apply.

The bylaws of America's First Federal Credit Union allow nominations by petition to serve on the board of directors. Nomination petitions must contain the signatures of at least 500 members who are at least 19 years of age and in good standing. In order to be considered, any nomination petition must be filed with the Secretary of the Board of Directors by 5:00 pm on March 10, 2022. All signatures on the petition are subject to verification by the Supervisory Committee.


